

**Data protection information on the transfer and integration of the contractual portfolio of Commerzbank Zrt. into Erste Bank Hungary Zrt.**

Dear Client,

We would like to hereby inform you that in the course of the acquisition of Commerzbank Zrt., a Hungarian subsidiary of Commerzbank AG, by Erste Bank Hungary Zrt. and the transfer of the contractual portfolio, the personal data that you have provided and that is currently processed by Commerzbank Zrt., which is necessary for the provision of services you have received, will be transferred to the extent necessary for the further provision of the services to Erste Bank Hungary Zrt. as future service provider.

The protection of personal data is of utmost importance for both Commerzbank Zrt. and Erste Bank Hungary Zrt., therefore, we provide you with brief information below on the essential circumstances of the data processing in accordance with Regulation 2016/679(EU) ("GDPR"):

1. Purpose of the data processing is the above transfer of personal data for the following purposes

- Ensuring the smooth handover and integration of clients taken over by Erste Bank Hungary Zrt. and the smooth continuation of services and banking transactions previously provided by Commerzbank Zrt.
- To communicate with data subjects and to adequately notify data subjects of a merger transaction, organise joint visits to contact corporate clients in order to provide information on the product portfolio of Commerzbank Zrt. to Erste Bank Hungary Zrt. to the clients taken over and presenting available new contractual arrangements based on this portfolio.

2. Legal basis of the data processing

- Legitimate interest of Commerzbank Zrt., Erste Bank Hungary Zrt. and the corporate clients of Commerzbank Zrt. pursuant to Article 6 (1) f) of the GDPR.

3. Personal data subject to the data processing

- Contact persons: name, position, contact details and language of correspondence,
- Cardholders, company executives, representatives, beneficial owners: personal data as defined in Articles 7-10 of Act LIII of 2017 on the Prevention and Combating of Money Laundering and Terrorist Financing
- Collateral providers: Identification data, contact details, personal data which may be provided in the course of certain contracts/orders, data provided by natural persons providing collateral for the purpose of collateral assessment and contracting.

You will find further detailed information on the transfer of personal data from Commerzbank Zrt. to Erste Bank Hungary Zrt., on the purpose and legal basis thereof, the categories of personal data transferred, as well as subsequent processing of personal data by Erste Bank Hungary Zrt. The data protection notices further contain detailed information on your rights regarding the processing of your personal data, including the right to object pursuant to Article 21 of the GDPR, and the manner of exercising such rights.
